Board Meeting Minutes December 9, 2014

Members in Attendance: Dr. Bounds, Charles Jarrett, Tracy Toy, Babbie Nelson

Others in Attendance: Pat Rawlings, Kim Moore, Scott James

Dr. Bounds called the meeting to order at 6:04 p.m.

Mr. James informed the Board that the Special Education students had done well in the State Special Olympics bowling competition. The entire Special Education department took a trip recently and received several compliments on their behavior. The GT program received good results on its recent monitoring visit. There were no changes to Mrs. Dauck's report.

There were no presentations by the PPC or NCPPC.

Tracy Toymade a motion to approve the Novemberminutes as presented. Charles Jarrettseconded the motion which was approved by a 4/0 vote.

Charles Jarrettmade a motion to approve the financial reports. Babbie Nelsonprovided a second, and the vote was 4/0.

The next item on the agenda was a request for mileage payments from aparent who transports their child. Mrs. Rawlings reported that the District has added a concrete pad and other improvements to aide in this student's mobility. Charles Jarrett made a motion to approve .42 per mile reimbursement retroactive to August 18, 2014. Tracy Toy seconded and the vote was 4/0.

Charles Jarrett made a motion to approve legal transfers for Cody Browning, Xavier Browning, and Kaylee Toney from Pocahontas to Maynard and Gregory Mast from Maynard to Pocahontas. Babbie Nelson seconded and the vote was 4/0.

In her Superintendent's report, Mrs. Rawlings informed the Board that the Elementary Math and Science night was well attended with 55 families represented. Nineteen staff members also attended. It was very well organized and informative. She also reported that the District was once again eligible for an ADE Title 1 grant. Maynard has received the grant in the past, although we were not eligible last year. Test results and data indicate that Reading should be a focus area for our District. In closing, she mentioned that the District was looking for a long-term sub for a teacher who would be taking an extended medical leave.

The Board entered Executive Session at 6:29 and returned at 7:13.

Charles Jarrett made a motion to accept the verbal resignation of bus driver, William Benton. Babbie Nelson provided a second and the vote was 4/0.

Tracy Toy made a request to hire Aaron Jarrett as bus driver and 20 hour/week maintenance. Babbie Nelson seconded and the vote was 4/0. Dr. Bounds suggested that all full-time employees of the Maynard School District receive a nonrecurring, one-time bonus up to \$500. Charles Jarrett made the motion, Babbie Nelson seconded and the vote was 4/0. Charles Jarrett made a motion to adjourn. Tracy Toy seconded and the vote was unanimous.
