At 7:11 p.m. Trent Melton opened the regular session.


Dr. Bounds made a motion to re-hire all personnel for the 2022-2023 school year. Cody Edington seconded that motion and it carried 4/0.


Cody Edington made the motion to accept the resignation of Agri/FFA teacher Cecile Draper. Brittany Byrd seconded that motion and vote was 4/0.
