Board Meeting Minutes April 12, 2016

Dr. Steve Bounds called the meeting to order at 6:00 p.m.

No additions were made to the High School Principal's report. Mr. James added to the Elementary report that they will be celebrating Founder's Day May 6th with Mrs. Shore.

No presentations were made by the Certified or the Classified PPC.

Melissa Perkins made the motion to approve the minutes from the previous meetings. Babbie Nelson seconded and the motion carried 5/0.

Melissa Perkins made a motion to approve the financial reports. Charles Jarrett provided a second, and the vote was 5/0.

Charles Jarrett made the motion to re-hire all Classified staff as recommended by Principal Scott James, Principal Cindy Dauck, Food Service Director Rhonda McCurter, and Superintendent Rawlings. Clint Seagraves made the motion to hire Stephanie Cline for the position of Bookkeeper. Babbie Nelson seconded and vote was 5/0.
